Hence, he prays to grant further time to execute the sureties.

4.Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl.Side), this petition is ordered and the time for executing the sureties is extended by one week from the date of receipt of a copy of this order as last chance.
