3.The learned Government (Crl.Side) submitted that the petitioner has been complying with the condition regularly.

Taking into consideration the fact that the petitioner is complying with the condition regularly and there is no complaint of the petitioner tampering with the witnesses, the condition imposed by this Court in Crl.O.P(MD)No.6377 of 2019 on 29.04.2019 is relaxed. However, the petitioner shall report before the respondent as and when required for interrogation.
