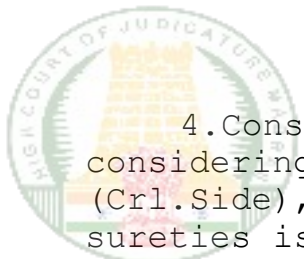

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of MR.C.MAYILVAHANA RAJENDRAN, Advocate for the petitioner and of Mrs.M.ANANTHA DEVI, Government Advocate (Crl.Side) on behalf of the Respondent, the court made the following order:-

This Petition has been filed to extend the time granted by this Court in Crl.O.P.(MD)No.2048 of 2019, dated 12.02.2019, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioner would submit that since there was some difficulty in arranging sureties he could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court.
