To modify the condition imposed by this Honourable Court in the order dated 15.05.2019 passed in Crl.OP(MD)No.6687 of 2019.

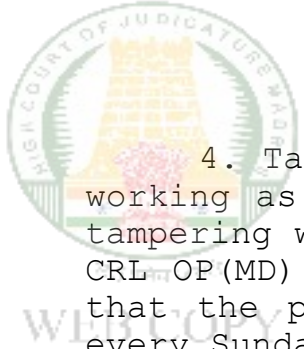
ORDER : The Court Made the following order :-
