PETITION FOR TIME EXTENSION Under Sec.482 of Cr.P.C.

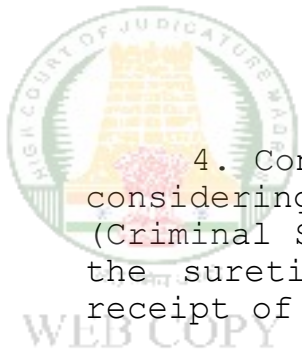
PRAYER :-

To extend the time granted in Crl.OP(MD)No.6238 of 2019 dated 27.04.2019 on the file of this Honourable Court, while granting anticipatory bail to the petitioners.

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.6238 of 2019, dated 27/04/2019, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioner would submit that since he is unable to execute sureties he could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Criminal Side), this petition is ordered and the time for executing the sureties is extended by one week finally from the date of receipt of a copy of this order as a last chance.
