PRAYER :-

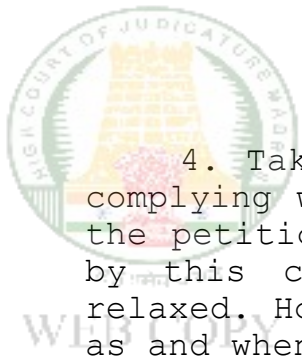
To Relax the condition imposed on them in Crl.O.P (MD) No. 6415 of 2019 dated 30.04.2019.
