To extend the time dated 15.06.2017 in Crl.OP(MD)No.9121 of 2016.

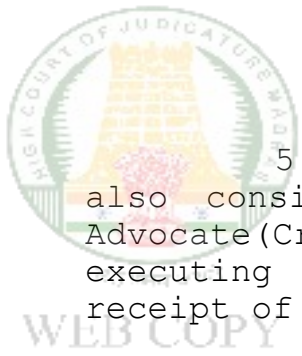
**ORDER :** The Court Made the following order :-
