PETITION FOR MODIFICATION Under Sec.439 (a) (b) of Cr.P.C

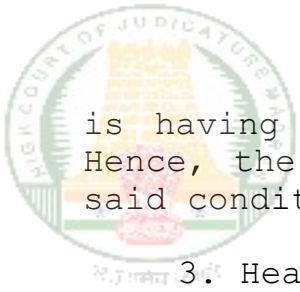
PRAYER :-
