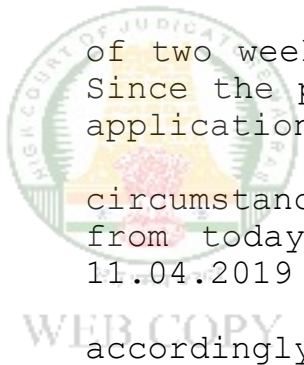
ORDER:-
