PRAYER :-

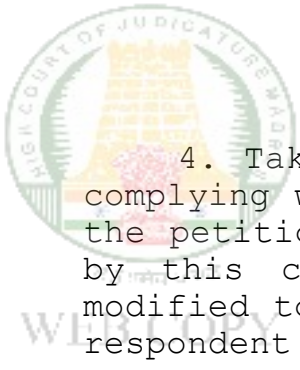
To relax the condition imposed in Crl.OP(MD)No.6870 of 2019 dated 16.05.2019.
