PRAYER :-

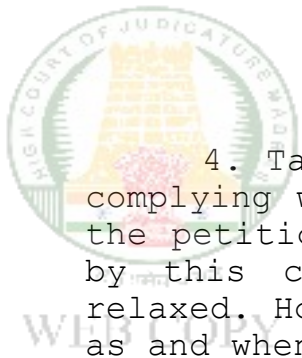
To relax the condition imposed on the petitioners in Crl.OP.
