PRAYER :-

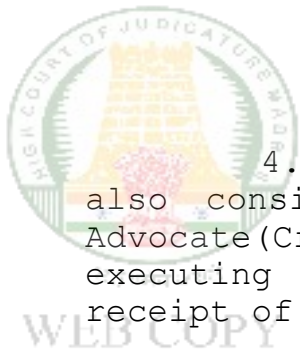
To extend the time for compliance of the orders passed by this Hon'ble Court on 15.05.2019 in Crl OP(MD)No.7095 of 2019.

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.7095 of 2019, dated 15/05/2019, for producing the sureties and for excuting the bail bond.

The learned counsel appearing for the petitioner would submit that since he is unable to furnish sureties he could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
