PRAYER :-

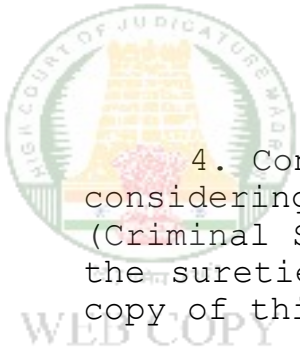
To extend the time in Crl.OP(MD)No.1965 of 2019 dated 07.02.2019 to the petitioner for surrender before the concern Court.

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.1965 of 2019, dated 07/02/2019, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioners would submit that since he is unable to furnish sureties they could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court.
