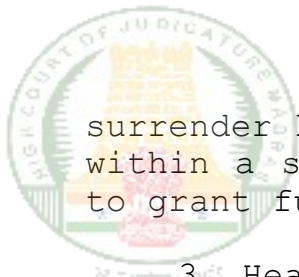
PETITION FOR TIME EXTENSION Under Sec.482 of Cr.P.C.
