PRAYER :-

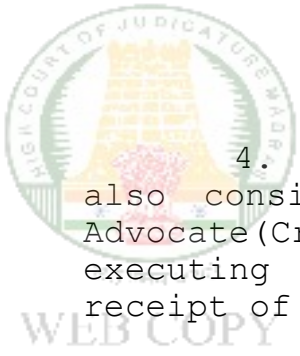
To extend the time granted in Crl OP No.5482 of 2019 dated 11.04.2019 for produce sureties.
