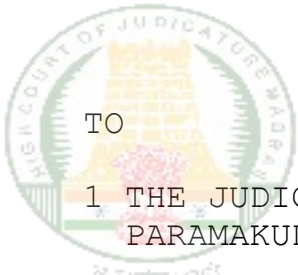
This petition has been filed to extend the time granted by this Court in Crl.O.P(MD) No.269 of 2019 dated 31.01.2019.
