PRAYER :-

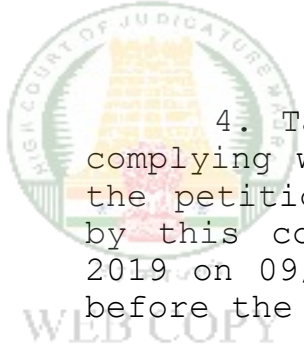
