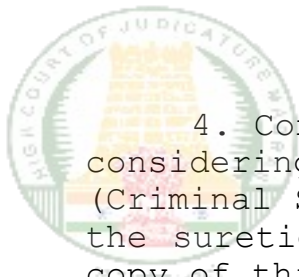

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.7160 of 2019, dated 15/05/2019, for producing the sureties and for executing the bail bond.

2. The learned counsel appearing for the petitioners would submit that since he is unable to furnish they could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, they pray to grant further time to execute the sureties.
