PRAYER :-

ORDER : The Court Made the following order :-

The petition has been filed to extend the time granted by this court in CRL OP(MD) No.7353 of 2019, dated 29/05/2019, for producing the sureties and for executing the bail bond.

2. The learned counsel appearing for the petitioner would submit that since he is unable to furnish sureties she could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, she prays



to grant further time to execute the sureties.
