PETITION to condone the absense Under Sec.482 of Cr.P.C

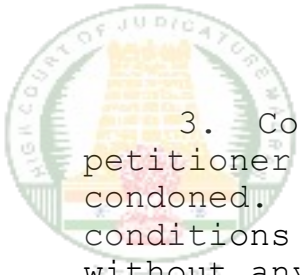
PRAYER :-

The learned counsel for the petitioner would submit that as per the order passed by this Court in Crl.O.P(MD) No.5532 of 2019 dated 12.04.2019, the petitioner herein has surrendered before the learned Judicial Magistrate No.II, Karur on 03.05.2019 and executed bail bond and thereafter he appeared before the respondent police daily at 10.30 a.m till 07.05.2019 and on 07.05.2019 the petitioner has met with a road accident and he was admitted in the hospital and discharged on 08.06.2019 and hence he could not appear before the respondent police on those days.
