PRAYER :-

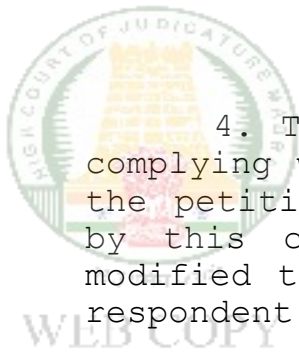
To relax the daily condition imposed by this Honourable Court in Crl.OP(MD)No.7580 of 2019 vide order dated 29.05.2019.
