PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

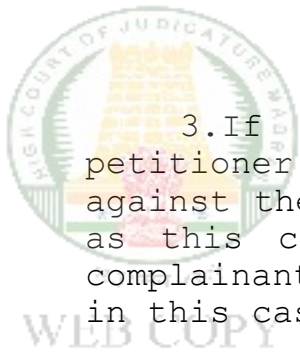
PRAYER :-

3.If the accused persons have encroached the land of the petitioner herein, it is open to the petitioner to lodge a complaint against the said accused persons and workout his remedy. In so far as this case is concerned, the petitioner is neither a defacto complainant nor victim and hence he is not entitled to participate in this case.

4.Considering the aforesaid facts, the petitioner has no locus standi to oppose the main criminal original petition.

5.Hence, this criminal miscellaneous petition is dismissed.
