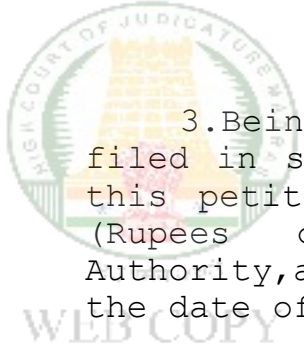
PRAYER IN CRL RC(MD) No.SR12957 of 2019:-
