Headmistress of the petitioner school from the date of appointment ie., 19.05.2010 with all consequential benefits.

The Petitioner seeks leave to file the present Contempt Petition by contending that though she is not a party in the order passed in the W.A(MD)No.551 of 2019, dated 13.6.2019, in effect, the said order was passed directing the appointment of the Petitioner herein, as Headmistress, which the respondent is yet to comply with. Therefore, he seeks permission.

2.Considering the order passed by this Court, We find that the Petitioner is certainly an aggrieved person, if the said order is complied with. Hence this Miscellaneous Petition is allowed.
