This petition seeks a direction to transfer the investigation of Crime No.8 of 2014 for the offences under Sections 120 B, 420, 465, 468, 471 and 506(i) IPC.

2. The learned counsel appearing for the petitioner wants



transfer of the file on the ground that a final report has not been laid.

3. The learned Government Advocate (Crl. Side) submitted that the FIR discloses that the offences are against land grabbing and the final report can be laid only before the concerned Land Grabbing Cell. Since the Special Court constituted for Anti Land Grabbing Cases are stayed by the Supreme Court, the Investigating Agency is in a position to lay the final report before the concerned Jurisdictional Magistrate only.

4. Considering the facts and circumstances of the case, since there is nothing to blame the Investigating Agency at this stage, the prayer for transfer of investigation cannot be maintained and accordingly, this Criminal Original Petition is dismissed.
