PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who was arrested and remanded to Judicial custody on 25.10.2018, for the alleged offence punishable under Sections 452, 395, 397 r/w.34 of IPC , 3 r/w.25(1-B) (A) Indian Arms Act in Crime No. 810 of 2002 (PRC.No.9 of 2007) seeks bail.

2.The crime is of the year 2002 and the case was registered in the year 2007, till date due to the non appearance of the petitioner, the trial court issued Non Bailable warrant against the petitioner and thereafter the petitioner was secured and remanded to judicial custody.

3.The learned counsel appearing for the petitioner would submit that the petitioner has been falsely implicated in this case and he has nothing to do with the alleged offence and hence, he would pray for bail.

4.The learned Additional Public Prosecutor appearing for the respondent police would submit that apart from this case there are ~~services courts on line~~ pending against the petitioner and hence he objected for grant of bail.



5. Considering the facts and circumstances of the case and considering the fact that there are several cases pending against the petitioner, this Court is not inclined to grant bail to the petitioner.

6. Hence the bail petition is dismissed.
