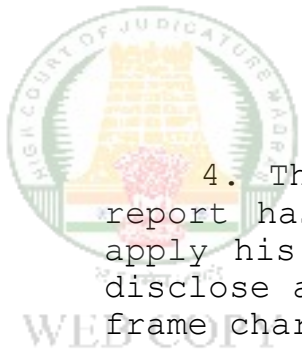

Inasmuch as the final report has also been laid, the learned Magistrate is directed to apply his mind to ascertain if the materials available before him disclose any commission of any offence under Section 506(i) IPC and frame charges.
