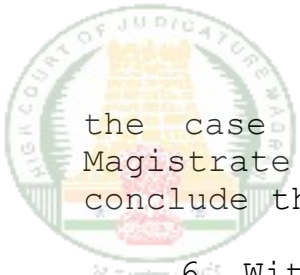
2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) for the respondents.

The learned counsel for the petitioner would submit that the FIR has been registered for the offence under Sections 147, 341, 342 and 448 IPC against the petitioner and others in Crime No.300 of 2013. After completion of enquiry, charge sheet has been filed and the same has been taken on file in C.C.No.337 of 2013 on the file of the learned Judicial Magistrate II, Madurai. Even though the petitioner was attending the case regularly, the trial in this case is not yet completed. Hence, the petitioner has approached this Court for speedy trial.

4. The learned Government Advocate (Crl.Side) appearing for the respondents would submit that ten witnesses have been cited by the prosecution and they are yet to be examined.
