Prayer in Crl.OP.(MD).No.2041 of 2019 :

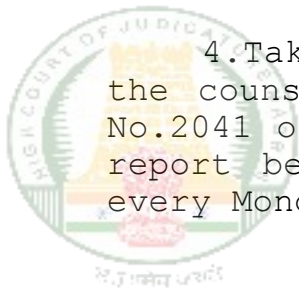
