ORDER

This petition has been filed to direct the learned Principal Sessions Judge, Special Court for PCR Cases, Theni, to accept the surrender of the petitioners and dispose of the bail petition filed by the petitioners on the same day in connection with Crime No.101 of 2019 on the file of the 2nd respondent Police.



Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioners are directed to surrender before the trial Court within a period of ten days from the date of receipt of a copy of this order and on such surrender, the learned Principal Sessions Judge, Special Court for PCR Cases, Theni, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15-A of the SC/ST Act.

3. This Criminal Original Petition is disposed of with the above directions. However, the petitioners are directed to take private notice to the victim intimating the date of their surrender.
