ORDER

This petition has been filed to direct the learned II Additional District and Sessions Court (PCR), Tirunelveli, to dispose of the bail application filed by the petitioner on the date of their surrender in connection with Crime No.118 of 2019 on the file of the 2nd respondent Police.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of ten days from the date of receipt of a copy of this order and on such surrender, the learned II Additional District and Sessions Court (PCR), Tirunelveli, shall deal with the matter on merits and in accordance with law, after issuing notice to the victims under Section 15-A of the SC/ST Act.
