However, the learned counsel for the review applicant/writ petitioner submitted that there is another prayer in the Writ Petition in W.P.(MD).No.24524 of 2018 with regard to the charge memo dated 30.11.2008 issued against the writ petitioner by the third respondent, which had not been dealt with by this Court and he prayed that it would suffice if liberty is given to file a separate Writ Petition challenging the said charge memo.
