The petitioner complains that the respondent police are dragging the investigation in the case registered in Crime No.116 of 2019 on the basis of the complaint that he had filed.

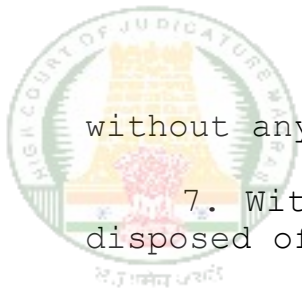
2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor.

5. Refuting the said statement strongly, the learned counsel appearing for the petitioner submitted that the accused persons are very much available in the Town and he can even provide the details of their whereabouts.

6. In view of the above, this Court now directs the Assistant Commissioner of Police (L & O), Thilagar Thidal Police Station, Madurai District, to oversee the investigation process and instructs him to ensure that the investigation is taken to his logical end
