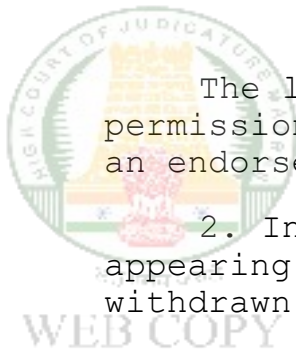
Prayer in CRL MP(MD). No.2479 of 2019 :-
