### **ORDER**

3. The learned counsel appearing for the petitioners submitted that the respondent police are harassing the petitioners.

4. The learned Additional Public Prosecutor submitted that a complaint was preferred by the third respondent and the same is being enquired as current paper. He further submitted that summon was issued to both the parties and petition enquiry was conducted and it was closed on 20.03.2019. He added that the respondent police have not harassed the petitioners and they have no intention to harass him.
