2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor.

3. The learned counsel appearing for the petitioner submitted that the petitioner has preferred a complaint with the respondent police, but he is not taking any action on his complaint.

Considering the above said statement of the learned counsel appearing for the petitioner, this Court holds that if the petitioner is aggrieved by any inaction on the part of the police on a complaint disclosing the commission of cognizable offence, then his remedy lies elsewhere in terms of the judgment of the Division Bench of this Court reported in **2018-2-L.W. (Crl.) 489 -**

[G.Prabakaran vs. The Superintendent of Police, Thanjavur District and another]. Therefore, the petitioner is directed to work out his

remedy in terms of the above said judgment.



5. Accordingly, this criminal original petition is disposed of.
