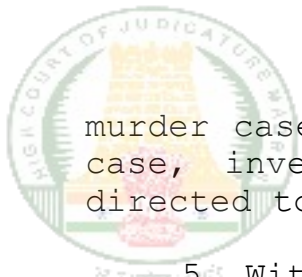
ORDER

3. The petitioner's wife is alleged to have been murdered and the case was registered in Crime No.10 of 2016. The third respondent police has filed report before the Court as 'undetected' and closed the matter.

4. This Court is not happy with the attitude of the third respondent in short-circuiting the process of investigation in a



murder case. Hence, the third respondent is directed to reopen the case, investigate the matter afresh. The second respondent is directed to monitor the course of investigation.
