2. The learned counsel appearing for the petitioners submitted that since the petitioners are residing at Manapparai, they feel hardship to appear before the Mahila Court, Cuddalore every day. Hence, he prayed for modification of the said condition.

Taking into consideration of the submissions made by both the counsels, the condition imposed in Crl.M.P.No.576 of 2018, dated 26.12.2018 by the learned I Additional District Judge, Tiruchirappalli, is modified to the effect that the petitioners shall stay at Madurai and report before the Anna Nagar Police



Station daily at 10.00 a.m until further orders. Further, it is made clear that the petitioners should not leave Madurai City until further orders.
