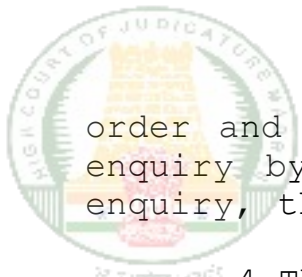

Therefore, the petitioner has filed this criminal original petition.

2.When the matter was taken up for hearing, the learned Government Advocate (Cr1. Side) appearing for the first and second respondents submitted that on the complaint given by the fourth respondent, an enquiry is pending and the summons were also issued to the concerned parties.

3.Considering the facts and circumstances of the case, the first respondent Police is directed to complete the enquiry within a period of one month from the date of receipt of a copy of this



order and the petitioner is also directed to co-operate with the enquiry by producing necessary documents. But on the guise of enquiry, the petitioner shall not be harassed.

4. The criminal original petition is ordered accordingly.
