ORDER

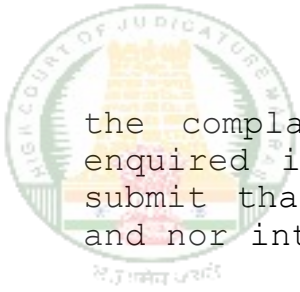
This petition has been filed seeking direction to direct the second and third respondents not to harass the petitioner under the guise of enquiry.
