PRAYER :-

To modify the first condition imposed in Crl.M.P(MD).
No.1353/2019 on the file of the Principal Sessions Judge,
Pudukkottai by order dated 15/06/2019.

ORDER : The Court Made the following order :-

This petition has been filed to modify the first condition
imposed by the learned Principal Sessions Judge, Pudukkottai
dated.15.06.2019.

2. The learned counsel for the petitioners would submit that
<https://hcservices.ecourts.gov.in/hcservices/> the petitioners herein were granted anticipatory bail by the
learned Principal Sessions Judge, Pudukkottai on 15.06.2019 with a



condition to deposit a sum of Rs.25,000/- before the Judicial Magistrate, Alangudi as cash security. He further submitted that they are unable to deposit the said amount, they have filed the present petition to modify the said condition.

3. The learned Government Advocate(Crl.Side) would submit that since the petitioners herein and nine others have damaged the defacto complainant's house and motor starter, electric board, pipeline worth about Rs.1,00,000/- the learned Sessions Judge has imposed the said condition. Hence she opposed to modify the said condition.

4. Considering the facts and circumstances of the case and also considering the allegation that the petitioners herein and others have damaged the defacto complainant's house and motor starter, electric board, pipeline worth about Rs.1,00,000/- the condition imposed by the learned Sessions Judge is modified to the effect that the each of the petitioners shall deposit a sum of Rs.10,000/- to the credit of Crime number 115 of 2019 before the concerned Judicial Magistrate within a period of ten days from the date of receipt of a copy of this order. All other conditions in the said order shall remain unaltered.
