Prayer in CRL RC(MD) . No.247 of 2019:

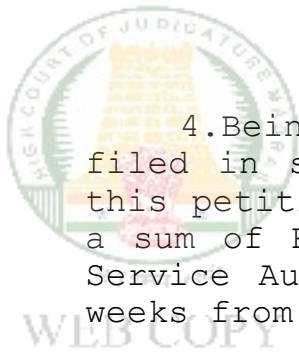
