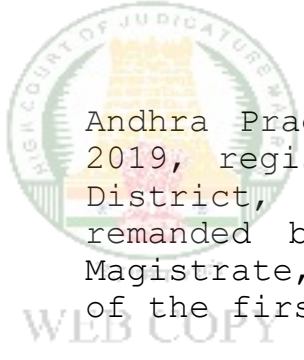
[Order of the Court was made by B.PUGALENDHI, J.]
