3. Sivaparvathi is produced before this Court. When we enquired her, she stated that she was in love with Vishnu (Respondent No.4) and since her parents had arranged for her marriage with another person, she decided to elope with the fourth respondent.

4. Since the alleged detainee is not in the illegal detention of anyone, no writ of habeas corpus can be issued. Hence, the Habeas Corpus Petition is closed.
