MUTHUMALAI, Advocate for 3rd Respondent, this Court made the following order:

Though the petitioner claims that he married the detenu, no proof of marriage has been produced, except the alleged text messages exchanged between them.

2. The learned Additional Public Prosecutor appearing for the State would submit that with regard to the complaint given by the petitioner, the mother of the detenu was enquired into and since



the detenu expressed her willingness to go with her parents-the third respondent, the matter has been closed.

3. However, taking into consideration the apprehension expressed by the petitioner, this Court asks the learned Counsel appearing for the third respondent as to whether she will produce the detenu, she undertakes to produce the detenu before this Court.

4. Call on 19.06.2019. The third respondent shall produce the detenu by then.
