(1) That the Judgment and Decree of both the Courts below be and hereby are confirmed and this Second Appeal is dismissed.

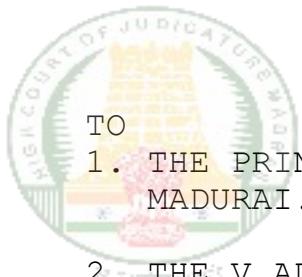
