Prayer in WP(MD). 21650 of 2018 : Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Declaration, declaring the rejection of the candidature of the petitioner with remarks as Does not possess required qualification published in the website of the Respondent No.1 on 12.10.2018 as illegal and consequently to direct the Respondent No.1 to select and appoint the petitioner to the post of Special Teacher (Physical Education) by calling the petitioner for counselling within the time stipulated by this Court.

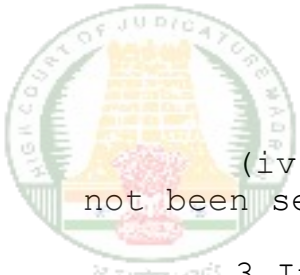
2.In the batch of the said writ appeals, this Court has observed and issued directions as follows:

(ii) The official respondents shall proceed further with the process of appointment in the manner known to law as their appointments will not be subject to the out come of connected writ appeals pending before this Court.
