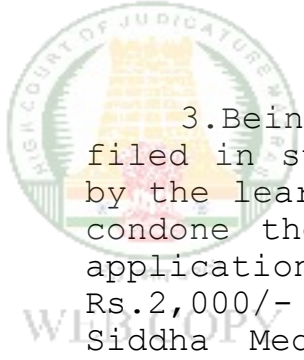

Accordingly, this petition is ordered.
