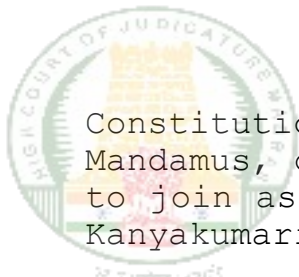
PRAYER IN REV.APLW(MD) No.SR15334 of 2019:
