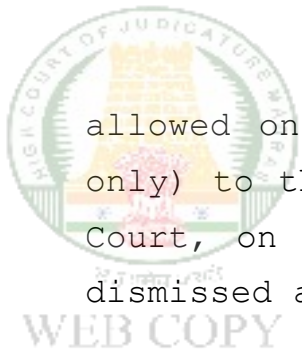
PRAYER in WP(MD)No.SR.89095 of 18:
